#### 1 Revision

This paper was revised on 3<sup>rd</sup> January 2022 in line with Alert Level 2.

### 2 Introduction

This paper should be read alongside the Statutory Covid 19 statement set out at appendix A.

The actions to be taken from this assessment shall be carried out until a further revision of this document is put in place.

## **3 Council Meetings**

Council Meetings shall be held by Zoom with facilities made available for those not on the internet to take part via audio link.

Council Meeting may only take place in person where a 2m distancing rule can be put in place.

The decision on how meetings will be conducted shall be made by the Chair and Town Clerk jointly.

## 4 Meetings with the public

Any meetings with the public individually or in pairs may take place as long as the 2m distancing rules apply.

## **5 Meetings with groups**

Meetings with groups shall be in line with the Level 2 guidance which shall be:

- a) Either by Zoom.
- b) Up to 30 only in a large room with 2m distancing achieved in all cases.

#### 6 Face masks

Face masks must be worn at all times indoors (unless seated) or outside where social distancing can be achieved.
